WE ARE READY TO DO OUR BIT FOR THE ENVIRONMENT

We are talking about a very important European Union directive, an effective strategy that will drive to in reduced pollution and therefore improve the life of citizens all over Europe. The ErP Directive (2009/125/CE) - the acronym stands for "**Energy Related Products**" - assesses very precise guidelines for design and the manufacturing of eco-compatible products and defines the minimum mandatory requirements for the efficiency and environmental performance of all power-consuming devices.

The goal is to reach the famous 20-20-20 by 2020. The repetition of the number 20 makes it easier to remember the **three key targets of the directive**:

- **INCREASE THE EFFICIENCY OF ENERGY USING APPLIANCES BY 20%**
- **REDUCE THE EMISSION OF CARBON DIOXIDE (CO₂) IN THE ATMOSPHERE BY 20%**
- **RAISE THE PERCENTAGE OF RENEWABLE ENERGY ON FINAL CONSUMPTION TO 20%**

Two deadlines have been set to establish a road map for the adjustment.

Starting from **1 AUGUST 2015** it will be mandatory **to place on the market** appliances fitted with energy efficient circulators.

Starting from **26 SEPTEMBER 2015** the ErP and ELD Directives will enter into force requiring energy labelling of all the appliances **placed on the market**.

Placing on the market means the first time the product is invoiced by Immergas to the dealer. If an appliance is placed on the market before 1 August/26 September 2015, **it can be sold, installed and put into service without time limits**. The ErP and ELD regulations are not retroactive.

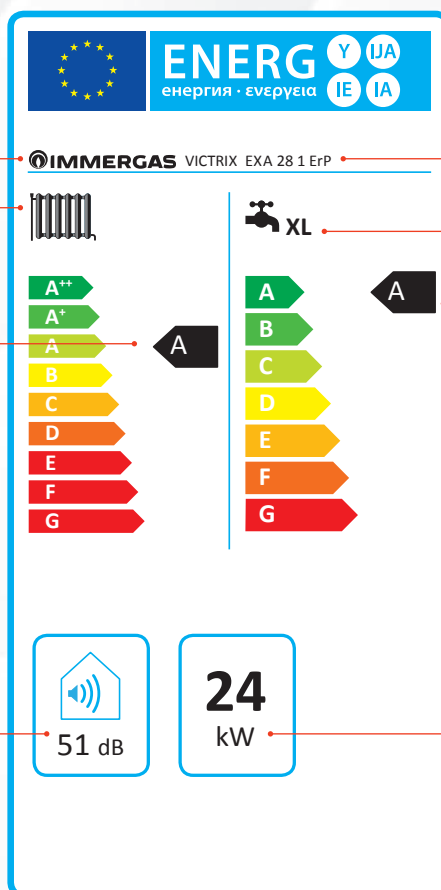

ELD: EVERYTHING CLEAR IN THE LABEL

The European Union has made the new energy labelling system mandatory to enable consumers to see immediately the level of environmental compatibility of every single product. The Energy Labelling Directive (2010/30/CE) requires every product subject to the ErP Directive to bear a label highlighting not only the energy efficiency class but also other performance factors such as sound power level, use and power consumption.

Efficiency and simplicity for lots of savings

The VICTRIX EXA ErP range offers **all the advantages of condensation together with total simplicity of use**. Boasting the technology most compatible with the new European Directives and with the aim of reducing energy consumption, it is the most effective solution for many new installations and replacements of existing systems.

VICTRIX EXA ErP are available in two 28 and 32 kW instant versions and in a 24 kW model for heating only, all capable of contributing substantially to **raising the energy efficiency** class for heating.

Wall installation can be **indoors** and **outdoors in partially protected places**. The strengths of the range are the **reliability** and **quality of the stainless steel condensing module** and the performance of the **low-consumption pump**. Its **compact size** makes it convenient and easy to install.

The easy-to-use user interface has adjustment knobs, selection buttons and LCD display showing the operating status and any error codes. The **lower panel covering the connection pipes comes with the range**, while the connection kit is optional for all the models.





DOMINUS. THE APP FOR ONLINE BOILER CONTROL

VICTRIX EXA ErP can be remotely controlled by means of the new DOMINUS app (**available from December 2015**).

This simple, intuitive app lets you control your boiler and display operation data on your tablet, smartphone and portable PC.

Using the optional Wi-Fi transmitter kit (code no. 3.026273), installed before your modem/ router wireless (not supplied by Immergas), you can communicate with the boiler's circuit board from any location.

THE QUALITY OF STAINLESS STEEL

The stainless steel condensing module **ensures durability, high reliability and resistance** to the formation of condensate from cooling of the combustion products.

SIMPLICITY OF CONTROLS

The boiler has a highly-developed easy-to-use user interface with LCD display, selection buttons and adjustment knobs that allow for quick and easy temperature adjustments.

ECOLOGICAL BOILER

Reduced emissions of carbon monoxide (CO) and nitrogen oxides (NOx) results in VICTRIX EXA ErP **being rated class 5, the most ecological** one in the classification by European standards UNI EN 297 and UNI EN 483.

CLASS A CIRCULATOR

The low-consumption pump allows for significant energy savings in comparison with the traditional circulator and self-adjusts in response to flow rate fluctuations, for example when there are thermostatic valves or zone valves.



INDOOR AND OUTDOOR INSTALLATION

VICTRIX EXA ErP is **approved for outdoor installation provided it is partially protected** from the weather (rain and snow), for example by installing it under a balcony. An electrical resistance kit is available to expand antifreeze protection from -5 °C to -15 °C (cod. 3.017324).

VERSION "X"

VICTRIX EXA 24 X ErP, **can be combined with a separate storage tank unit** through a special optional kit (code 3.024907). The kit consists of 2 pipes to connect the three-way valve (standard in the boiler) at separate storage tank. The separate storage tank Units come in a range of models from 80 to 300 litres, to be selected according to the system requirements of domestic hot water production.

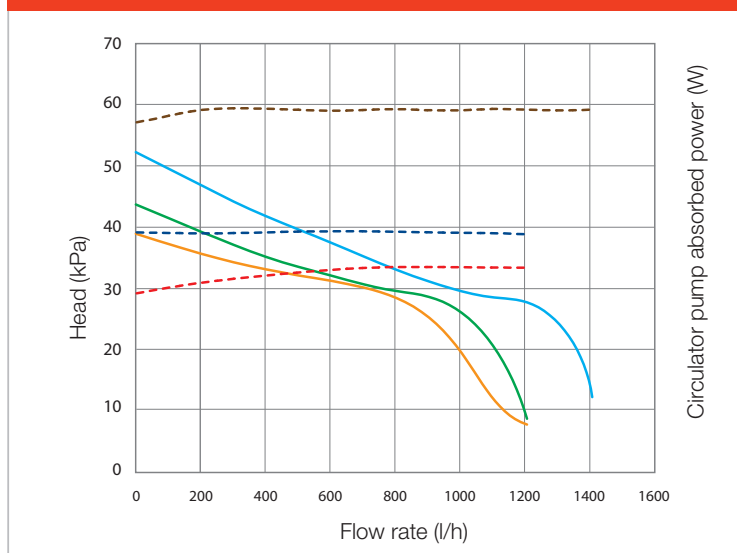

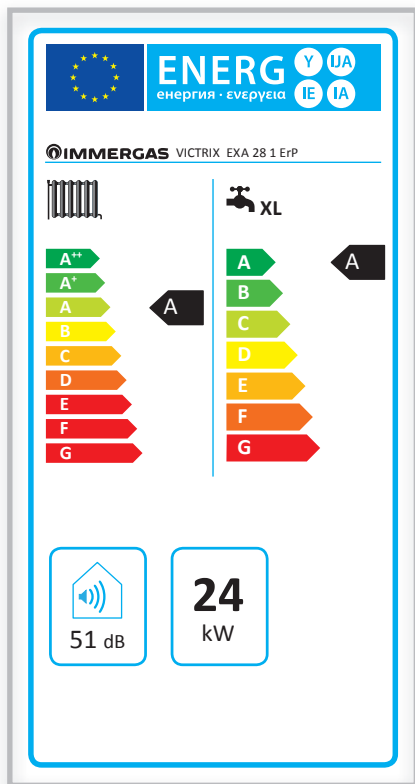

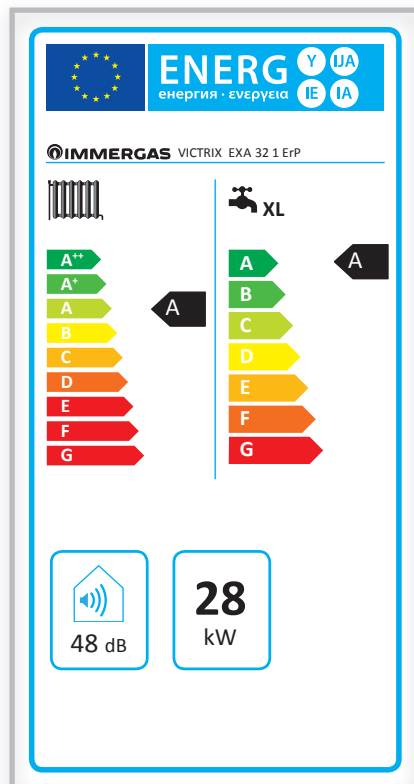
PRODUCT INFORMATION (in accordance with regulation 811/2013)

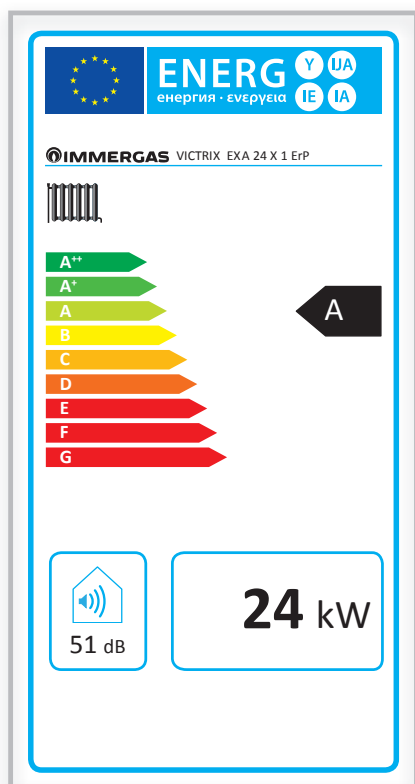
